NOMINATION CRITERIA

Members of **Trinidad and Tobago Fire Service Credit Union Co-operative Society Limited**, who are interested in offering themselves for service to the **Board of Directors, Supervisory or Credit Committee, Liaison Officers and Education Officer Tobago**, must complete and return this form in a sealed envelope, addressed to the **Chairman, Nominations Committee** to any **Fire Service Credit Union Office** or emailed to nominations@fscutt.com no later than **February 10, 2023, 3PM**.

Nominees SHALL be 'FIT AND PROPER' as outlined in the Co-operative Society's Act and SHALL satisfy the set criteria.

A Nominees Shall:

1. Be over the age of eighteen [18] years, of good mental health and an active member of the society for at least two [2] years, as of **December 31, 2022**.
2. Not be in default in any loans, nor have a record of being in default/delinquent in any other financial institution for the past twenty-four [24] months, nor have been declared bankrupt.
3. Not have been convicted, nor at present before the court for an indictable or summary offence, especially for matters of dishonesty, fraud or money laundering.
4. Not be an employee of the **Trinidad and Tobago Fire Service Credit Union** nor any other Financial Co-operative.
5. Not be a member of another Credit Union **Board of Directors or Statutory Committee**.
6. Not have immediate family members or relatives serving on the current Board of Directors or any Statutory Committees, nor have any intimate personal relationships with a current member of the Board of Directors or any Statutory Committee.
7. Be prepared to submit themselves to training commensurate with the specific statutory committee for which you are interested in serving.
8. Be prepared to learn "Credit Unionism/Co-operative Principles."
9. Attend all official meetings and conscientiously conduct the business of the Board and Committees.

Should the nominees possess the following qualities/qualifications it will be considered an **asset**:

- a) Have some experience or qualification in; credit union management, accounting/financial management, law, human resource management, leadership and management and a commitment to service.
- b) Very passionate about the Co-operative ideology and Credit Unionism.
- c) Be committed to giving generously of their time to serve the society.
